Our Exhibitor Expo promises to be one of the highlights of the conference this year. Each booth will consist of a 6' skirted table, with a wastebasket and sufficient chairs provided.

In addition to the charges described below, any additional hotel charges (such as shipping, electrical, or internet access) are the responsibility of the Exhibitor.

LEVEL ONE

Exhibitor -- \$500 - \$2,499. This entitles the company to a booth and 2 of their staff members to attend the Exhibitor Day (including any presentations that day) without paying the registration fee of \$300. If they wish to stay for the entire conference, they would pay the registration fee. Participation in the Exhibitor lunch is included.

LEVEL TWO

Contributor -- \$2,500 - \$4,999. This entitles the company to a booth and 2 of their staff members to attend the conference for the entire week without paying the registration fee. It also includes 2 complimentary tickets to NCACC's annual banquet.

LEVEL THREE

Sponsor is any company who pays \$5,000 or more. This entitles the

company to a booth, an opportunity to present a vendor showcase, and for 3 of their staff members to attend the conference for the week without paying the registration fee. It also includes 3 complimentary tickets to our annual banquet.

LEVEL FOUR

Partner is any company who pays \$20,000 or more. This entitles the company to 2 booths, an opportunity to present a vendor showcase, and for 5 of their staff members to attend the conference for the week without paying a registration fee. It also includes 5 complimentary tickets to our annual banquet.

For a \$500 additional fee, LEVELS ONE and TWO may present a vendor showcase on a first-come, first-serve basis.
