Featuring a vendor exposition and opportunities for showcase presentations to members of the NCACC, joined in 2008 by members of the Conference of Appellate Technology Officials (CATO).

The NCACC Vendor Expo will take place from 12:00 to 5:00 pm on Wednesday, August 6, 2008. The Expo is always a highlight of the conference. In Pittsburgh, members of the Conference of Appellate Technology Officials (CATO) will join the NCACC Membership for the Expo and Showcases. Four levels of participation are available:

1. Exhibitor -- \$500 - \$2,499. This entitles the company to a booth and two of their staff members to attend the Exhibitor Day (including any presentations that day) without paying the registration fee of \$300. If they wish to stay for the entire conference, they would pay the registration fee. Participation in the Vendor Lunch is included.
2. Contributor -- \$2,500 - \$4,999. This entitles the company to a booth and two of their staff members to attend the conference for the entire week without paying the registration fee. It also includes two complimentary tickets to NCACC's annual banquet.
3. Sponsor is any company who pays \$5,000 or more. This entitles the company to a booth, an opportunity to present a vendor showcase, and for three of their staff members to attend the conference for the week without paying the registration fee. It also includes three complimentary tickets to our annual banquet.
4. Partner is any company who pays \$20,000 or more. This entitles the company to two booths, an opportunity to present a vendor showcase, and for five of their staff members to attend the conference for the week without paying a registration fee. It also includes five complimentary tickets to our annual banquet.

Returning in 2008 – Vendor Showcases

Each Expo booth will consist of a 6' skirted table, with a wastebasket and sufficient chairs provided. In addition to the charges described here, any separate charges for conference events, and any additional hotel charges (such as shipping, electrical, presentation equipment or internet access) are the responsibility of the Vendor. **The in-house audio/visual provider for the hotel can be reached at (412) 562-1200 extension 2109.**

For a \$500 additional fee, LEVELS ONE and TWO may present a vendor showcase on a first-come, first-serve basis.
